USER AGREEMENT: By using this card, user agrees to the following: Card expires 30 days after first use. Maintenance fee up to 65c may apply after first use and periodically thereafter. Taxes and other surcharges apply. Calls using toll-free access are subject to surcharge of up to 5¢ per minute. All calls are subject to a distribution fee of up to 40%. Long call charges exceeding 4 minutes may be subject to a long call charge of up to 10¢ per minute. Calls are billed in three-minute increments. All calls made from payphones will be assessed up to 95¢ surcharge in accordance with FCC regulations. Network service provider and/or Distributor are not responsible for local telephone charges incurred by the customer in gaining access to local telephone network. Published rates, surcharges, fees and billing increments vary and are subject to change without prior notice. Prompted minutes exclude fees and other surcharges. Rates are higher for international cellular, Alaska and Hawaii termination. Higher rates apply to calls originated from Alaska, Hawaii, and Canada. Connection fee of 25c applies after first use. International rates vary by country. Call Customer Service for specific charges, fees and rates. Additive charges apply to destinations other than the Philippines. Calls to toll-free information services and directory assistance are not available with this card. Scratched, damaged or used cards are not refundable. The distributor and/or the network provider are not responsible for lost, stolen or misused cards. This card has no surrender value and is not refundable.
